2. Feedback & actions from previous meeting

County Lines

- Concern county lines pushed into the backwater a little bit. Become normalised.
- Separate issues identified
 - Child CL entrenched and evident in YMCA high need houses.
 - New cohort of vulnerable adults being involved (victim perpetrators)
- Not wanting to criminalise YPs but needing to report illegal behaviour
- VW talk at Crawley community college young people opened up about the

- Lived experience needed where can this be found?
- PB Friend who has lived experience but there are many threads that create a difficulty to get any help to those that need it. Jason Eade working with young people previously, could this expand?
- Willingness to use forum as a vehicle to express voluntaru sector concers and appetite to be more involved.
- Exploitation team at the police talk to them to involve in coming forums...

ACTION - Set up action sub-committee of forum members to co-ordinate better communication with police and collaborative approach to some of the local issues identified.

3. Early releases

What extra pressures & how organisations have adapted?

- PB High needs and risk clients at Clock Tower Sanctuary
- DK Early releases hve actually been happening over a over a longer period but this has increased with 40% of sentence
- DK Probation 'reactively monitoring' after 66% of licence. Request that other services are feeding back information relating to adherence to licence conditions.
 - MW Could this be better communicated?
- TB Is very high now a standard term DK yes a mappa 3 and immediate risk to others, these not included in early release or RESET.
- DK Unfortunately, there are more high-risk offenders being released and this was the only option.

Discussion

- Push towards community orders which has increased workload on CGL and other services.
- Everyone now looking for sentence review for guidance on future working practices – they are looking for feedback currently.
- Remand problem as there is no support on release from court and no plan or time as to release.
- DK Looking at how to support remand, court releases and end of sentence releases.
- CGL Really struggling to keep up with release and recall merry-goround.

New commissioning to support a voluntary sector communication, possibly managed by Clinks type organisation.

Discussion of contract management across the KSS and how much funding has disappeared to larger 'contract management' organisations.

MP from BoB – explanation of service and how they work with and request to work more closely with the community organisations.

- Discussions of how they work and how their participants benefit.
- Need to keep some mystery about their 'weekends' but reassured that it is all positive and helps manage behaviour etc.

Sarah from Become – National charity working with care leavers up to 27. Range of free services helping people to understand their legal care services and help with extra support. Can connect to help available for YPs that they are eligible for. Can also offer staff training for working with care leavers.
